I would like to thank all our customers for your continual support, and we look forward to working even closer with you as we weather the storm ahead together.



NOTICE: COMPLETE RESTRICTION OF IMO CARGO TO LEBANON

Due to the Beirut port blast of 4th August 2020, the Lebanese customs have put recently very strict conditions on the storage of Imo cargo as LCL in the warehouses of the Lebanese ports, which cannot be met by any of the currently operating logistics companies.

Import by FCL is still possible under certain conditions that importers have to meet and present to the authorities prior to shipment.





Due to the COVID-19 quarantine requirements for the ship crew on board the coastal feeders running between South China and Hong Kong waters, feeder operators announced their services to be suspended from mid-Jan to late Feb 2021.

In consequence of the above, our services between Hong Kong, and Fuzhou, Xiamen and the entire Pearl River Delta will be greatly affected. Below are the list of the affected destinations:

There will be no service from Hong Kong to the abovementioned destinations from 15 Jan to 23 Feb 2021, with the exception of Macau which will not have service from 02 Feb to 23 Feb 2021.

The perennial peak season and pre-Chinese New Year Holiday shipment rush will lead to further congestion. As such, there will be expected delays in shipments, including transhipment via Hong Kong and Hong Kong export services. The above situation in Hong Kong will persist all the way going into the Chinese New Year period.

To mitigate the situation, please consider routing your cargo via other hubs such as Singapore and Busan.
